## Manuscript submission and Authors' responsibilities

The preparation of scientific papers should essentially be in accordance with the Uniform Requirements for Manuscripts Submitted to Biomedical Journals (Ann Intern Med 1997; 126: 36–47). The language of the journal is German (with Abstracts in English). Manuscripts should submitted in English or German (with an English Abstract) and should be sent directly to the Production Editor and submitted in an electronic format (via e-mail).

Articles should include a title page with the names, academic degrees and addresses of all authors, summary, and keywords. The text of scientific articles should be composed of Introduction, Material and Methods, Results, Discussion, Acknowledgments (if applicable) and References. Articles other than scientific papers may have a different outline, but should be divided by subheadings and always contain a summary. Figures should be submitted separately in an electronic format (jpeg, tiff, resolution min. 300 dpi, or as Excel files). All figures and tables must be mentioned in the text and be supplied separately together with a short caption.

All manuscripts are subject to peer review.

Scientific manuscripts submitted will be published free of charge for authors after they have passed the peer review process. Upon acceptance for publication, copyright of the article is transferred to mhp Verlag GmbH.

All authors named in the manuscript have to have significantly contributed to the research. The designated principal author will receive proofs for final approval. All authors are obliged to provide retractions or corrections of mistakes, if applicable. A list of references has to be provided with the manuscript. References must be listed in the numerical order of their appearance in the text (not alphabetically).

A conflict of interest statement essentially in accordance with the International Committee of Medical Journal Editors (www.icmje.org) has to be completed and signed by all authors, stating affiliation with and/or financial support from the industry. Manuscripts already published or submitted for publication elsewhere cannot be considered for publication.

# **Peer review process**

All manuscripts are subject to peer review. All manuscripts will be reviewed by two reviewers from the Advisory Editorial Board and assigned to review the specific manuscript by the editor in chief, observing possible conflicts of interest. Reviewers' identity will not be disclosed to authors.

The reviewers' comments will be made available to the authors including possible recommendations for amendments. A repeat review after revising the manuscript and resubmission may be necessary.

If conflicting recommendations regarding the acceptance for publication occur, the editor in chief will re-evaluate the manuscript and reviewers' comments.

#### **Publication ethics**

Publishers and editors shall take reasonable steps to identify and prevent the publication of papers where research misconduct has occurred. They shall not encourage such misconduct, or knowingly allow such misconduct to take place. In the event that the publisher or editors are made aware of any allegation of research misconduct the publisher or editor shall refuse publication of the article in question, or in case of a published manuscript, publish a retraction, correction and apologies when needed.
